IRRIGATION EQUIPMENT and WELL DATA:

EAST PIVOT: (8) tower Electrogater pivot, 125 hp electric motor and Fairbanks irrigation pump, electric control panel, Registered NE Irrigation well G-024744 with 129.2 Upper Republican NRD certified irrigated acres was drilled 1965 to 270'. Drilling time stats for this well are available from Broker. This well does need some work or may need replaced. The pump is currently sitting near the bottom of the well.

The irrigation well is located in the building site being retained by the Seller. A well use agreement will be provided for the Buyer for the life of the well. This well is on it's power service meter.

Soils under the east pivot are 39% Class II Haxtun fine sandy loam and 61% Class IV and VI Dailey and Valent loamy sand.

<u>WEST PIVOT:</u> (10) tower Electrogator pivot, 125 hp electric irrigation motor, Sargent irrigation pump, electrical control panel, Registered NE Irrigation well G-061568 with 129.7 Upper Republican NRD certified irrigated acres was drilled in 1979 to 380', static water 146', pumping level 160' at drilling time. Currently, the pump set at an unknown depth and is rated at 900 gpm.


Soils under the west pivot 34% Class IV Dailey loamy sand and 66% Class VI Valent loamy sand.

Both irrigation wells are pooled together for NRD management. The usage in '23 was averaged out at 10.2". The pool has 52.3" left for the current allocation period which is 2023-2027. They have 107.35" of carryforward.

FSA BASE INFO: Farm is enrolled in PLC with 265 acres corn base at 150 bushel yield and 15.3 acres wheat base with 39 bushel yield. Base will transferred with approval of the FSA County Committee.
